Humanizing Deportation and International House are pleased to present Humanizing Deportation, a multimedia exhibition and series of community dialogues, in collaboration with artists and organizations working locally and in Tijuana on immigration policy and its personal reverberations. Featured works include more than fifty testimonial narratives of deportation, portraits of digital story authors taken in Tijuana by Leopoldo Peña, silkscreen posters by local artists of TANA, and original drawings by artist and digital story author Juana Mendez.

Free and open to the public, the month-long installation and series of community events will present first-hand stories of detention and deportation, provide insight and training on how to become an ally, and explore the role of artistic expression in advocating for social justice and advancing political change.

Part II. Creative responses to the exhibition are encouraged. Artworks made by the public in response to the exhibition will be featured in Spring 2019 at International House Davis. Humanizing Deportation / Humanizando la Deportación is an ongoing project and bilingual online archive of digital stories documenting a diverse range of personal experiences related to deportation that give a human face to the consequences of mass involuntary displacement.

Taller Arte del Nuevo Amanecer (TANA) is a collaborative partnership between the Chicana/o Studies Program at the University of California, Davis and the greater Woodland community. TANA offers a fully functioning silkscreen studio, Chicano/Latino Arts exhibition space, and a teaching center for the arts. Through exhibiting, printing, and teaching, TANA cultivates the cultural and artistic life of the community, viewing the arts as essential to a community's development and well-being.

International House Davis (I-House) fosters connections, new experiences, and original perspectives within a global framework. Through programs that are collaborative, inclusive, and accessible, we strive to provide substantive engagement with our region's richly diverse communities and the world. Founded in 1981, the organization is a 501(c)3 nonprofit located in Davis, California.
